### Description:

This report lists all Calls for Service for a given Township, Village, or City within the provided date range.

A Call for Service is defined as a single event for a single department. For instance, multiple deputies may respond, but one Call for Service is generated. A cross-agency event will generate one CFS per agency. CFS may be generated by citizen requests or self-initiated by a first responder. The nature of the CFS may evolve over the life of the event and the most recently updated nature is provided.

This report includes CFS for all agencies, including police, fire, and EMS, that are dispatched through the Integrated Dispatch center. Responses from Portage DPS, WMU DPS, or fire agencies outside the county are not included.

If a CFS results in an extended investigation, a case/Incident will be generated, and further updates occur within the Incident. For crime statistics, see reports based on Incident data, such as the UCR Reports.
