MINUTES OF THE REGULAR MEETING OF THE COOPER CHARTER TOWNSHIP BOARD HELD ON MONDAY, SEPTEMBER 12, 2016

The regular meeting of the Cooper Charter Township Board was held on Monday, September 12, 2016 at the Cooper Charter Township Hall, 1590 West D. Avenue, Kalamazoo, Michigan.

Project Superintendent Mark Wordon gave a presentation on the Kalamazoo County Road Commission general information including number of employees, miles of local roads, funding sources for road work and expenditure budget for 2016. He also talked about road maintenance, winter maintenance, road surface evaluation and 2016 local and primary road projects and how to fund the needed projects in the township.

The board and audience were asked if there were any questions for the Kalamazoo County Road Commission. The board and citizens thanked the road commission for the presentation.

Citizens were offered an opportunity to address the board regarding subjects not on the agenda.

Comments were made about the recent sewage that was dumped into the Kalamazoo Riverview due to an equipment failure at the Sewage Treatment Plant. There was also a concern for bike riders and safety on township roads.

Avenue Sewer, Riverview Industrial Sewer, Henshaw/Moffett Sewer, Delinquent Special Assessments and Levied Liens on the Tax Roll, and reaffirm Investment Policy.
