Cooper Fire Department... Cooper Fire Department held two training sessions in the month of May. The Firefighters trained on physical readiness in the 1st drill and water/ boat operations in the other. There were 59 calls for service this month bringing the year-to-date total to 277. Every spring and early summer, Cooper Fire Department responds to several calls that are a result of weather. Storms often cause power lines and



trees to come down in and near the road ways. Power lines should always be treated as if they are energized. Call the local utility company when you see a down power line, be careful and stay away from them, call 911 if they pose a serious threat.

Zoning 101 – Ordinances to Know

Accessory Buildings – Interested in constructing a new pole barn or placing a portable yard barn on your property? Accessory buildings are permitted if a principal home exists on the property. A highlight of the regulations is provided below with the full accessory building requirements found in ordinance **120.410**: Accessory Uses or Buildings.

A single portable accessory structure not exceeding 200 square feet in area or 20 feet in height, and which is mobile and not permanently affixed to the ground, is allowed, in addition to any other accessory buildings on the property. A free Zoning Compliance Permit is required.

Pole barn size is based on the acreage of your property and a building permit is required.

Property Size	Maximum for all Accessory Buildings	Maximum Building Height	Maximum Building Length
No restrictions on size if you have over 3 acres			
Less than 1 acre	1,080 sq. ft.	20 ft.	36 ft.
1 acre to 1.99 acres	1,280 sq. ft.	Maximum height of Zoning District	40 ft.
2 acres to 2.99 acres	1,680 sq. ft.	Maximum height of Zoning District	No restriction

Solar Panels – Both roof and ground mounted solar panels are permitted on residential property. Ground mounted systems must be placed in the rear yard and meet all setbacks. They require site plan review and approval by the Township before a building permit is issued. Roof mounted equipment just requires a building permit. Additional regulations can be found in ordinance **120.470**: **Solar Energy Systems**.

Livestock and Honeybees are permitted on single-family zoned properties. Small animals (generally under 35 pounds) like chickens and rabbits are permitted with no specific acreage requirements. However, your lot needs to be large enough to accommodate the small animal in a way that does not impact public health, safety, and welfare. The number of larger animals is based on your property acreage and require approval from the Township. The full list of rules can be found in ordinance **120.480**: **Noncommercial Keeping of Livestock and Honeybees**.

2022 Summer Tax Bill

The summer tax bill you're receiving is due by September 14, 2022. Additional interest of 1% per month accrues beginning September 15, 2022.

If you plan to mail your tax payment, please consider using our drop box (located to the right of our front door) or dropping it off at the post office in a secure receptacle. We have all read the stories about criminals stealing mail out of rural mailboxes in order to commit different types of check fraud.

At this time Cooper Township Office doesn't accept credit or debit card payments. Online payments can be made through **www.pointandpay.com**. Please be aware.....<u>Point and Pay charges a 3% convenience fee for this service.</u>

Whether you send in a check or initiate an online payment through your bank, please call our office or check online at <u>www.coopertwp.org/assessments-and-taxes/</u> to confirm that your payment was received. We have had several instances recently when our office has not received the payment. This results in your account being turned over to the Kalamazoo County Treasurer's Office as delinquent which means additional interest and penalty that you will be responsible for.



The Federal Government has extended the deadline for REAL ID to May 3, 2023. When it does go into effect, this federally required standard for identification means anyone who travels by air within the United States will be unable to board a plan without a REAL ID compliant document. A REAL ID will also be required to enter certain federal facilities. Make an appointment now at a Secretary of State office to turn your standard drivers' license or ID into a REAL ID!
