

HHW Center Numbers Update

Despite major road construction for the majority of 2023 on Lake Street, there was slight increase in participation and pounds of HHW wastestreams (excluding electronics) in 2023 over 2022. This chart shows the distribution of 283,215 pounds by percentage of each type.



*Lab-Packed Materials: acids, aerosols, ammonia, ammunition, bases, cleaners, fire extinguishers, flares, mercury, organic peroxides, oxidizers, PCB ballasts, poisons/toxics, 1-lb propane cylinders, unused sharps/injectable medications.

We also collected 220,867 pounds of electronic waste.
